prevail as governed and approved by the United States Golf Association and the Royal and Ancient Golf Club of St. Andrews, Scotland. Except where local rules apply.

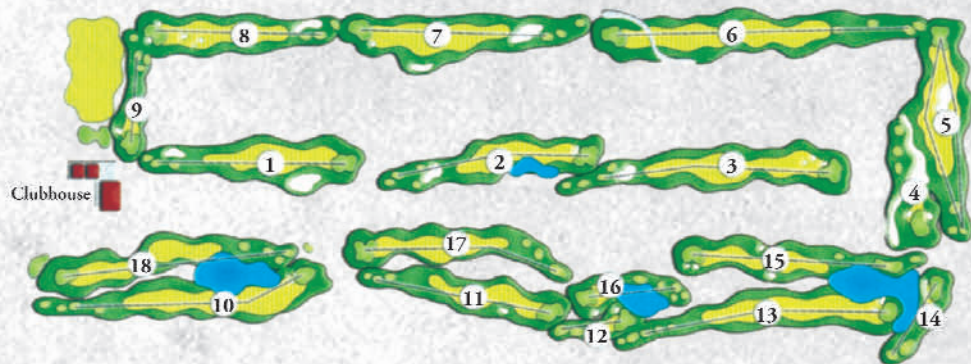
LOCAL RULES OF PLAY

- Ball coming to rest in desert - Player may drop a ball within two club lengths of the nearest point of relief, no nearer the hole. One stroke penalty.
- Lateral water hazards are defined by red stakes and lines.
- No coolers or alcohol may be brought onto the premises.

- Out of bounds is defined by perimeter fences, inside edge of all private property walls adjacent to holes, and the inside edge of any roadway curbing. Play is prohibited from out of bounds including from within the practice area adjacent to Hole 9.

- Immovable obstructions - cart paths, rock borders, buildings on course, and staked trees. Free relief. (Rule 24-2)

- One club length stance and swing relief is authorized from all curbed edges of lakes & marked environmental areas.
